Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee (“Committee”), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the Little America Flagstaff, located at 2515 East Butler Avenue, Flagstaff, Arizona 86004, commencing on August 7, 2023, at 1:00 p.m., and will continue each weekday on August 8, 2023, through August 11, 2023, as necessary, at the same location beginning at 9:00 a.m. on each day, unless a tour is taken. If a tour is taken, it will begin on alternative date and time set by the Chairman of the Committee (“Chairman”).

Public comment will be taken in a special evening session on August 7, 2023, at 5:30 p.m. and may be taken at the beginning of each hearing day or at other times during the hearing at times designated by the Chairman. Unless later ordered by the Chairman,

1 the hearing will adjourn at approximately 5:00 p.m. each day, except on August 7, 2023,  
2 when it will continue after 5:30 p.m. for the public comment session.

3 No tour of the Project area is planned by the Chairman at this time. If the  
4 Chairman or Committee later decides to conduct a tour, notice that includes a map and  
5 itinerary of any such tour will be available at the hearing and posted on the Project website  
6 at [www.obedmeadowsolar.com](http://www.obedmeadowsolar.com) and the ACC website at: [https://www.azcc.gov/arizona-](https://www.azcc.gov/arizona-power-plant/meeting-schedule)

8 The hearing may conclude earlier or later than anticipated, depending upon the  
9 number of parties that intervene, the amount of testimony presented, the amount of public  
10 comment, and the time needed for deliberations by the Committee. As a part of the public  
11 meeting/hearing, members of the Committee will discuss the potential value of a tour, and,  
12 at the discretion of the Chairman, may tour the location of the proposed project area as set  
13 forth above.

14 **THE PUBLIC HAS THE OPTION TO PARTICIPATE BY EITHER**  
15 **WATCHING THE MEETING ONLINE OR LISTENING TO THE MEETING VIA**  
16 **TELEPHONE.**

17 At least 24 hours in advance of the hearing, information regarding online and

23 relating to the application will take place, except on the record before a court  
24 reporter at the designated stops. The Chairman will make any procedural  
25 decisions concerning stops at different points of interest;

27 environmental compatibility and conditions to the certificate of
