

13 Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the
14 general public, the parties, and the Arizona Power Plant and Transmission Line Siting
15 Committee (“Committee”), that the Chairman has determined that this matter shall be
16 conducted by the Hearing Officer. The Hearing Officer will hold a public meeting/hearing
17 on the above application that is open to the public in the Commissioner Conference Room
18 on the second floor of the Arizona Corporation Commission (“ACC”) located at 1200 West
19 Washington Street, Phoenix, Arizona 85007, commencing on Wednesday, August 16,
20 2023, at 9:00 a.m. Public comment will be taken in an evening session on August 16,
21 2023, at 5:30 p.m. and may be taken at other times during the hearing at times designated
22 by the Hearing Officer.

23 The hearing may conclude earlier or later than anticipated, depending upon the
24 number of parties, the amount of testimony presented, and the amount of public comment.

25 **THE PUBLIC HAS THE OPTION TO PARTICIPATE BY EITHER**
26 **WATCHING THE MEETING ONLINE OR LISTENING TO THE MEETING VIA**
27 **TELEPHONE.**

1 At least 24 hours in advance of the hearing, information regarding online and
2 telephone hearing access as well as any additional details regarding safety protocols or
3 other revisions to the hearing schedule, will be posted on the Applicant's Project website
4 at <https://www.cecwinchestertransmission.com> and ACC website at
5 <https://www.azcc.gov/arizona-power-plant/meeting-schedule>. The Hearing Officer may,
6 at his discretion, recess the hearing to a time and place to be announced during the
7 hearing, or to be determined after the recess. The date, time, and place at which the
8 hearing will be resumed will be posted on the above-noted Project and ACC websites.

10 **HOWEVER, PUBLISHED NOTICE OF SUCH A RESUMED HEARING IS NOT**
11 **REQUIRED.**

12 **PUBLIC COMMENT WILL BE TAKEN IN A SPECIAL EVENING**
13 **SESSION ON AUGUST 16, 2023, AT 5:30 P.M., VIA TELEPHONE, ZOOM, OR IN**
14 **PERSON AT THE ACC, LOCATED AT 1200 W. WASHINGTON STREET,**
15 **PHOENIX, ARIZONA, 85007. PUBLIC COMMENT MAY ALSO BE TAKEN AT**
16 **OTHER TIMES DURING THE HEARING AT THE DISCRETION OF THE**
17 **HEARING OFFICER.**

18 **PLEASE BE ADVISED THAT ALL LOCAL AND STATE PUBLIC**
19 **HEALTH AND SAFETY GUIDELINES WILL BE FOLLOWED DURING THE**
20 **PUBLIC HEARING AND PUBLIC COMMENT SESSION. RESTRICTIONS ON**

- 6. Adjournment.
