Commission warns of Bogus Solicitation “United Filings” Soliciting Businesses for Certificate of Good Standing

(Phoenix) The Corporation Commission warns business owners about a solicitation that urges them to pay for services to get their Certificate of Good Standing. The solicitation comes from a company called United Filings and appears legitimate because it includes the recipients company’s name, address, and entity number.

The Arizona Corporation Commission has no affiliation with United Filings. Business owners can obtain a Certificate of Good Standing through the Commission’s website <http://ecorp.azcc.gov>.
