**ORIGINAL**B. DEFINITIONS

For the purpose of this tariff, the following definitions shall apply:

1. Access Line  
A dedicated arrangement which connects a customer location to an Carrier NSC (See below for definition).
2. Administrative Change  
The modification of an existing circuit, dedicated access line or port, at the request of the customer, that involves changes in authorization codes, speed numbers, route guide, consolidation of billing, verification of testing performed by parties other than Carrier, or any other administrative change not covered by a Billing Record Change. (See below for definition)
3. Allnet  
Global Crossing Telecommunications, Inc.
4. Allnet Dedicated Service  
A.D.S.
5. Allnet Tariff FCC No. 5 and 8  
That tariff filed by Carrier with the Federal Communications Commission and known as Frontier Communications International, Inc. Tariff FCC No. 5 and 8, as amended, from time to time.
6. Application for Service  
A standard Carrier order form which includes all pertinent billing, technical and other descriptive information which will enable Carrier to provide the communication service as required. The order form may be completed by an Carrier employee using information obtained by telephone.
7. Authorization Code  
A multi-digit code, one or more of which are available to Metered Use Service customers to enable them to identify individual users or groups of users, and thereby allocate the costs of their long distance service, except where Equal Access Dialing is used by the customer and costs are allocated on the basis of the telephone number from which the customer uses the service.

8. Billing Record Change  
A change in customer billing address, telephone number or a change from one billing package to another using the same access method.
9. Cancellation of Order (This differs from a disconnection, see below for definition).  
A customer initiated request to discontinue processing a service order, either in part or in its entirety, prior to its completion. Cancellation charges will be assessed for each dedicated access line canceled from an order prior to its completion by Carrier under the following circumstances:
- (1) if the local Telco has already confirmed in writing to Carrier that the dedicated access line will be installed; or
  - (2) if Carrier has already submitted facilities orders to an interconnecting telephone company.
10. Circuit Termination  
The point at which Carrier's circuit originates, terminates, or drops for the insertion or removal of a customer's signal.
11. Customer  
The person, firm, corporation or other entity which orders service, including the ordering or use of Equal Access Dialing,-- either for its own use, as an Other Common Carrier, or as a non-profit manager a sharing group--and which is thereby responsible for payment of charges and for compliance with Carrier tariff regulations. For billing purposes, a customer is considered to be an account. If a customer orders an authorization code or orders or uses Equal Access Dialing, in more than one Carrier originating city, or requests the assignment of Authorization Code in a particular city, each such account is a separate customer for billing purposes.

12. Customer-provided Terminal Equipment  
Terminal Equipment, as defined herein, provided by a customer.
13. Disconnection  
The disconnection of a dedicated access line or port connection being used for existing service. (This differs from a Cancellation; see above for definition.)
14. Equal Access Dialing  
The use of service through Telco Equal Access facilities allowing the customer to access Carrier's NSC through either a "1+" or 10XXX dialing sequence. Customers using Equal Access Dialing may be billed to the telephone number from which the Equal Access Dialing originates.
15. Installation  
The connection of a dedicated access line or port for new or additional service.
16. Joint User  
A person, firm, or corporation designated by the customer as a user of communication facilities furnished to the customer by Carrier, and to whom a portion of the charges for such facilities are billed under a joint user arrangement.
17. National Holidays  
Carrier-recognized National Holidays are New Year's Day, Fourth of July, Labor Day, Thanksgiving Day and Christmas Day.
18. Network Switching Center (NSC)  
Any location where Carrier has a network switch installed.

19. Network Trunks  
Access lines, interswitch trunks, and circuits connecting services and facilities of Carrier or other carriers to Carrier NSC's.
20. Off-Network Access Line  
A local exchange, foreign exchange, or WATS line connecting both incoming and outgoing traffic from a Carrier switched service network to the public switched network.
21. Other Common Carrier (or Interexchange Carrier)  
A person, firm, corporation or entity regulated by the FCC or by any state public utility commission which sells communication services and facilities to the public for profit, including resellers.
22. Permitted User  
A person, firm, corporation or other entity permitted by the customer to receive or send communications. Such permission includes, without limitation, 1) the use of the customer's Authorization Code where the Authorization Code has been made known to the user by the customer, its employees or agents, and 2) the use of customer's telephone number when Equal Access Dialing is used.
23. Physical Change  
The modification of any existing dedicated access line or port, at the request of the customer, requiring same physical change or determination.
24. Premises  
The space designated by a customer as its place or places of business for termination of CARRIER service.
25. Service Group  
One or more A.D.S. dedicated access lines terminated in the same multiline terminating device at the same customer premise.
26. Special Promotional Offering  
Special discounts or modifications of its regular service offerings which Carrier may from time to time, offer to its customers for a particular service. Such offerings may be limited to certain dates, times and locations.

**ORIGINAL**C. RULES AND REGULATIONS1. Description of Service

.01 Carrier is an interexchange common carrier furnishing communications services between specified locations under the terms of this tariff.

.02 Carrier, when acting at the customer's request, and as his authorized agent, will make reasonable efforts to arrange for service requirements which may include terminal equipment, circuit conditioning or Equal Access Dialing.

2. Limitations

.01 Service is offered subject to the availability of facilities and the provisions of this tariff.

.02 Carrier reserves the right to discontinue furnishing service, upon five (5) days written notice, when necessitated by conditions beyond its control or when the customer is using the service in violation of the provisions of this tariff, or in violation of law.

3. Terms and Conditions

.01 Service is provided and billed on the basis of a minimum period of at least one month, beginning on the date that billing becomes effective, and continues to be provided until canceled, by the customer, in writing, on not less than thirty (30) days notice. In the event a customer order an Carrier Option that does not require a monthly subscription fee, Carrier reserves the right to treat a period of non-use of not less than 90 days as a cancellation and to discontinue furnishing service, without notice, after such 90 day period.

.02 Service is offered on a monthly basis.

.03 For the purpose of computing charges in this tariff, a month is considered to have 30 days.

.04 The name(s) of the customer(s), including members of a sharing group, desiring to use the service must be stipulated in the application for service.

### 4. Liability

- .01 The liability of Carrier, for whatever reason, shall not exceed an amount equivalent to the proportionate charge otherwise payable for the period of time during which any mistake, omission, interruption, delay, error or defect, or any other event giving rise to a claim, occurs. In no event shall Carrier be liable for special, consequential or incidental damages.
- .02 Carrier shall be indemnified and held harmless by the customer against.
- .021 claims for libel, slander, or infringement of copyright arising out of the material, data, information, or other content transmitted over Carrier's channels; and
- .022 patent infringement claims arising from combining or connecting Carrier's furnished channels with apparatus and systems of the customer; and
- .023 all other claims arising out of any act or omission of the customer in connection with any service provided by Carrier.
- .03 Carrier is not liable for any act or omission of any other company or companies furnishing a portion of the service.
- .04 Carrier does not guarantee or make any warranty with respect to any equipment provided by it where such equipment is used in locations containing an atmosphere which is explosive, prone to fire, dangerous or otherwise unsuitable for such equipment. The customer indemnifies and holds Carrier harmless from any and all loss, claims, demands, suits or other action, or any liability whatsoever, whether suffered, made, instituted or asserted by the customer or by any other party or persons, for any personal injury to or death of any person or persons, and for any loss, damage or destruction of any property, whether owned by the customer or others, caused or claimed to have been caused directly or indirectly by the installation, operation, failure to operate, maintenance, removal, presence, condition, location or use of such equipment so used.

- .05 The customer indemnifies and holds Carrier harmless from any and all loss, claims, demands, suits, or other action, or any liability whatsoever, whether suffered, made, instituted or asserted by the customer or by any other party or persons, for any personal injury to, or death of, any person or persons, and for any loss, damage, or destruction of any property, whether owned by the customer or others, caused or claimed to have been caused directly or indirectly by the installation, operation, failure to operate, maintenance, removal, presence, condition, location or use of such equipment where such installation, operation, failure to operate, maintenance, condition, location or use is not the direct result of Carrier's negligence.
- .06 Carrier is not liable for any defacement of, or damage to, the premises of a customer resulting from the furnishing of channel facilities or the attachment of instruments, apparatus, and associated wiring furnished by Carrier on such customer's premises or by the installation or removal thereof when such defacement or damage is not the result of Carrier negligence. No agents or employees of other participating carriers shall be deemed to be agents or employees of Carrier.
- .07 The customer is responsible for taking all necessary legal steps for interconnecting his customer - provided terminal equipment or communications systems with Carrier facilities. Customer shall secure all licenses, permits, rights-of-way, and other arrangements necessary for such interconnection.
- .08 The customer shall ensure that his equipment and/or system is properly interfaced with Carrier facilities, that the signals emitted into Carrier's network are of the proper mode, bandwidth, power, data speed, and signal level for the intended use of the customer and that the signals do not damage Carrier equipment, injure personnel or degrade service to other customers. ### 4. Liability (Cont'd.)

#### .08 (Cont'd)

certifying body certifies terminal equipment as being technically acceptable for direct electrical connection with interstate communications service, Carrier will permit such equipment to be connected with its channels without the use of protective interface devices. If the customer fails to maintain and operate his equipment and/or system properly, with resulting imminent harm to Carrier equipment, personnel, or the quality of service to other customers, Carrier may, upon written notice, require the use of protective equipment at the customer's expense. If this fails to produce satisfactory quality and safety, Carrier may, upon written notice, terminate the customer's service.

### 5. Cancellation of Service By A Customer

If a customer cancels his order for service before the service begins, before completion of the minimum period, or before completion of some other period mutually agreed upon by the customer and Carrier, a charge will be levied upon the customer for the nonrecoverable portions of expenditures or liabilities incurred expressly on behalf of the customer by Carrier and not fully reimbursed by installation and monthly charges. If, based on an order by a customer, any construction has either begun or been completed, but no service provided, the nonrecoverable cost of such construction shall be charged to the customer.

### 6. Use of Service

.01 The services offered herein may be used for, one or more of the following:

.011 for the transmission of communications to or by the customer.

.012 for the transmission of communications to or by a permitted user or joint user.

.02 Service may be arranged for joint use or permitted use. The joint user or permitted user shall be permitted to use such service in the same manner as the customer, but subject to the following:

.021 One joint user or permitted user must be designated as the customer. The designated customer does not necessarily have to have communications requirements of his own. The customer must specifically name all joint users or permitted users in the Application for Service. Orders which involve the start, rearrangement, or discontinuance of joint use or permitted use service will be accepted by Carrier only from that designated customer and will be subject to all regulations in this tariff.

.022 All charges for the service will be computed as if the service were to be billed to one customer and any discount arrangements will be based on the actual number of circuits installed at the beginning of the billing period. The customer shall be responsible for allocating charges to each joint user or permitted user.

.03 Service may be arranged for use by Other Common Carriers for the purposes of resale subject to the following:

.031 Other Common Carriers will be responsible for charges, costs, etc. incurred by Carrier with respect to Services as referenced in Section D.

.032 Other Common Carriers are responsible for all interaction and interface with their own subscribers or customers.

.04 Service shall not be used:

.041 for any unlawful purpose

.042 for any purpose for which payment or other compensation is received by the customer, except when the customer is a duly permitted and regulated common carrier. This provision does not prohibit an arrangement between customer, permitted user or joint user to share the cost of the service so long as this arrangement generates no profit for anyone participating in a joint use or permitted use arrangement.

7. Payment Arrangements

.01 The customer is responsible for payment of all charges for services furnished to the customer or any permitted user through customer's Authorization Code or Equal Access Dialing telephone number. Charges for installation, physical or administrative changes, or for cancellation of orders are payable upon completion. Recurring charges, including estimated usage where applicable, are billed in advance. Estimated usage charges are determined by Carrier based on the customer's projected use of service, or, at Carrier's option, on the highest previous monthly usage charges incurred by the customer.

.02 Bills will be payable upon receipt. Interest at the rate of 1½ percent per month (unless prescribed by law, in which event at the highest rate allowed by law), will accrue upon any unpaid amount commencing twenty (20) days after rendition of billing.

.03 Applicants or customers whose financial condition is not acceptable to Carrier may be required at any time to make a deposit up to an amount equaling the installation charges, if applicable, and/or up to two months actual or estimated charges for the service to be provided. In the case of a cash deposit, interest at the rate as may be prescribed from time to time by the Arizona Corporation Commission will be paid for the period during which the deposit is held by Carrier. At Carrier's option, such deposit may be refunded or credited to the customer at any time prior to termination of service.

.04 The charges set forth in this tariff for circuit terminations contemplate installations made in normal locations and under normal working conditions. Any installations to be made under other circumstances are subject to additional charges, which will be tariffed as appropriate.

.05 If notice of a dispute as to charges is not received, in writing, by Carrier within three months after an invoice is rendered, such invoice shall be deemed to be correct and binding upon the customer.

8. Change in Service Agreement

When a change in service arrangement involves the continued use by the customer of circuits furnished by Carrier, installation charges do not apply to the circuits continued in use. The minimum service period for the circuits contained in use is determined from the date of the initial installation thereof.

9. Restoration of Service

The use and restoration of service in emergencies shall be in accordance with Part 64, Subpart D of the Federal Communications Commission's Rules and Regulations, which specifies the priority system for such activities.

10. Inspection

Carrier may, upon reasonable notice, make such tests and inspections as may be necessary to determine that the requirements of this tariff are being complied with in the installation, operation or maintenance of customer's or Carrier's equipment. Carrier may interrupt the service at any time, without penalty to Carrier, because of departure from any of these requirements.


