



Monthly Purchased Gas Adjustor Rates for Arizona Natural Gas Local Distribution Companies

This page is meant to provide natural gas customers in Arizona with information on the monthly change in their rates, related to the changing cost paid by Arizona natural gas local distribution companies for the natural gas commodity. Shown below is a table for each Arizona natural gas local distribution company, showing the purchase gas adjustor rate and bank balance amortization rate (aka PGA surcharge) applicable to each month.

Billing Month - the rate shown for each month is the rate applied to all applicable bills sent to customers during that month.

Purchased Gas Adjustor (PGA) Rate - this rate adjusts automatically each month to reflect the average cost of gas for the most recent 12-month period for which information is available, subject to certain limitations.

PGA Bank Balance Amortization Rate - this rate is a temporary surcharge or credit, approved by the Commission, which allows the local gas distribution company to reduce the over or under-collected PGA Bank Balance. The PGA Bank Balance becomes over or under-collected when the local gas distribution company recovers more or less through its tariff rates than what it paid for its natural gas supplies.

On July 3, 2003, the Commission approved the acquisition of Citizens Utilities Company's natural gas assets in Arizona by UNS Gas, Inc., as well as the merger of the Northern Arizona and Santa Cruz Divisions. New natural gas rates under UNS Gas, Inc. went into effect August 11, 2003. Monthly PGA data is shown under Citizens Utilities through August 2003 and under UNS Gas, Inc. beginning in September 2003.

On July 25, 2003, the Commission approved the acquisition of Black Mountain Gas, including the Cave Creek and Page Divisions, by Southwest Gas. There is no change to the treatment of the monthly PGA rate as a result of the acquisition for Page Division customers. Cave Creek Division customers began paying the Southwest Gas PGA rates beginning in November 2003. Cave Creek Division customers began paying all Southwest Gas rates beginning in July 2004. Monthly PGA data for the Cave Creek Division is shown under Southwest Gas beginning in July 2004. It should be noted that the information shown in this table is accurate to the best of our knowledge, but each Company's approved rate schedules should be consulted to ensure the accuracy of PGA related rates.

Beginning in April 2006, Southwest Gas' Purchased Gas Adjustor (PGA) Rate also includes the gas cost component known as the base cost of gas, which previously was included in a different portion of Southwest's rates.
