FOREIGN BUSINESS CORPORATION
APPLICATION FOR WITHDRAWAL BY DULY AUTHORIZED OFFICER**
Pursuant to A.R.S. §10-1521

This form is to be used only for foreign corporations that have not issued stock or have not conducted business, and that if they have done either, they need to complete form CF0025.

A. FILING FEE: \$25.00. EXPEDITED SERVICE AVAILABLE FOR AN **ADDITIONAL** \$35.00 (add \$35 to the filing fee). [A.R.S. §10-122.(A)(16) AND (F)(2).

B. THERE IS NO REQUIREMENT FOR EITHER PUBLICATION OR A TAX CLEARANCE FROM THE ARIZONA DEPARTMENT OF REVENUE.

C. THE DOCUMENT SHALL BE TYPEWRITTEN OR PRINTED AND SHALL BE LEGIBLE AND CAPABLE OF MICROFILM. [A.R.S. §10-120.(D).]

D. THE DOCUMENT AND ANY EXHIBITS TO THE DOCUMENT SHALL BE IN THE ENGLISH LANGUAGE OR ACCOMPANIED BY AN ENGLISH TRANSLATION CERTIFIED AS ACCURATE BY OR ON BEHALF OF THE PERSON CAUSING THE DOCUMENT TO BE DELIVERED FOR FILING. [A.R.S. §10-120.(E).]

E. THE WITHDRAWAL MUST BE EXECUTED PURSUANT TO A.R.S. § 10-120.(F).

F. THIS FORM MAY BE USED BY A CORPORATION SUBJECT TO THE FOLLOWING REQUIREMENTS:
EITHER: 1. NONE OF THE CORPORATION'S SHARES HAVE BEEN ISSUED IN THIS STATE.
 2. THE CORPORATION HAS NOT COMMENCED BUSINESS IN THIS STATE.
