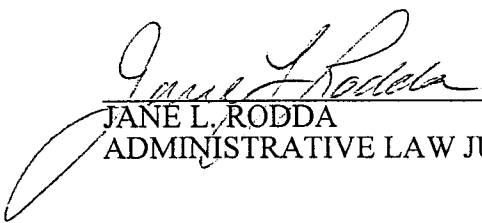
11 **BY THE COMMISSION:**

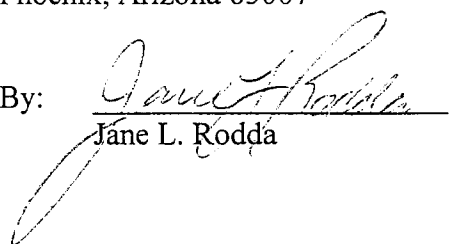
