Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee ("Committee"), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the Holiday Inn Case Grande, 777 N. Pinal Avenue, Casa Grande, Arizona 85122, commencing on Tuesday, April 17, 2017 at 2:00 p.m., and will continue each weekday on Wednesday, April 18, 2017 through Tuesday, April 25, 2017, as necessary, at the same location beginning at 9:00 a.m. on each day, unless a tour is taken. If a tour is taken, it will begin on Wednesday, April 19, 2017, at approximately 9:00 a.m. or an alternative date and time set by the Chairman of the Committee ("Chairman"). Public comment will be taken in a special evening session on April 18, 2017 at 6:00 p.m. and may be taken at the beginning of each

 hearing day or at other times during the hearing at times designated by the Chairman. Unless later ordered by the Chairman, the hearing will adjourn at approximately 5:00 p.m. each day.

Additional days for the hearing may be set, and the hearing may conclude earlier or later than anticipated, depending upon the number of parties that intervene, the amount of testimony presented, the amount of public comment, and the time needed for deliberations by the Committee.
