PROCEDURES FOR ESTABLISHING EXEMPT STATUS AT AN EXISTING CROSSING

1. Applicant (Sponsor) of the project <u>must</u> set up an on-sight meeting with all parties involved (Railroad, ACC Rail Safety Section, local government agency and law enforcement having jurisdiction over the roadway, school transportation departments i.e. city, state or county and any other party having interest in the proposed project).

Key information discussed at the on-sight meeting:

- Criteria for Exempt Crossing Eligibility
 - o Protection—The crossing shall be equipped with active signals.
 - Traffic Control Signals—Grade crossings where the railroad traverses through an
 intersection of two or more roadways and traffic is controlled by a traffic control signal
 may be considered under the same criteria as a crossing equipped with automatic gatetype signals.
 - Number of Tracks—The crossing shall not have more than one track in service.
 - Sight Distance—There shall be a clear and unobstructed view of the grade crossing from any point on the highway for a distance equal to the minimum stopping sight distance for the posted speed limit.
 - Warning Devices—The railroad crossing warning devices shall remain properly located and maintained except that warning devices located at a crossing where the track is out of service need not be maintained.
 - Train Speed—The maximum allowable train speed at the grade crossing shall be not greater than 20 miles per hour.
 - Accident History—The grade crossing shall not have had more than two vehicle-train accidents in the last five years. If the automatic gates have not been in service for five years, only that period covered by the automatic gates shall be applicable.
 - o FRA Inventory for the crossing must indicate "No Train Traffic".
- Current and ongoing maintenance surface, signing and striping
- Any issues in elevation track or road
- Sight visibility issues
- Current or future development
- Project schedule
- ACC process

2. Public Notice

 The party making application for the change is status must post signs on each roadway approach to the crossing notifying the public of the proposed Exempt Status. The signs must meet the specifications described below and read as follows:

NOTICE

Sign specifications: A metal sign with 1.5 inch black letters on a white background.

- A notice, stated in general terms, shall be given by mail to the operators of the vehicles affected by the exemption request. However, in those cases where notice by mail would be impractical because the operators involved cannot be reasonably ascertained or because the class of operators is so large that notice by mail would be costly, a notice by publication is sufficient. In such cases, notice should be placed in trade publications and newspapers of general circulation reasonably calculated to apprise the operators involved of the exemption request.
- 3. Making an Application to the Commission:
 - Required and begins the official ACC process
 - See Appendix A: Sample Application Contents. Answer all relevant questions.
 - ACC Rail Safety Staff may request additional data in preparation of the Staff Report. Staff will
 notify the Applicant within 15 days of receipt of the application of any deficiencies in the
 Application and may terminate the application if those deficiencies are not remedied within
 10 days of notice. Filing of a Staff Report on the Docket is considered acceptance of the
 application.
 - Applicant should efile the application through https://efiling.azcc.gov/. Alternatively, one original and thirteen hard-copies of the application may be filed with Arizona Corporation Commission, Docket Control, 1200 W. Washington St. Phoenix, AZ 85007.
 - o Docketed application will be scheduled for hearing by an Administrative Law Judge (ALJ)
 - A Procedural Order with instructions to be followed will be issued by the ALJ.
 - The Procedural Order will direct the applicant to provide public notice of the scheduled hearing. The applicant must file with the Commission Docket certification of the required public notice.

Failure to follow the Procedural Order may result in delaying the hearing process.

- 4. Public Hearing
 - Applicant and legal counsel must attend the scheduled hearing.
 - Approximately 30 days after the hearing, a recommended Opinion and Order from the ALJ will be issued.
- 5. Opinion and Order
 - The executed Opinion and Order of all applications is obtained by a majority 'yes' vote by the Commissioners at the next scheduled Open Meeting.
 - Applicant and legal counsel should plan on attending.
- 6. The process from Application to Opinion and Order generally takes about 120 days, depending on hearing and open meeting calendars.

PROCEDURES FOR RESUMING TRAIN OPERATIONS AND REMOVING EXEMPT STATUS

1. Applicant (Sponsor) of the project <u>must</u> set up an on-sight meeting with all parties involved (Railroad, ACC Rail Safety Section, local government agency and law enforcement having jurisdiction over the roadway, school transportation departments i.e. city, state or county and any other party having interest in the proposed project).

Key information discussed at the on-sight meeting:

- Public notice
- Joint inspection of signals and track
- Maintenance concerns surface, signing and striping
- Any issues in elevation track or road
- Sight visibility issues
- Current or future development
- Project schedule
- ACC process

2. Public Notice
