SECTION 4. RULES AND REGULATIONS.

4.1. Lifeline Service.

4.1.1. Federal Lifeline Program.

The Federal Lifeline Program is designed to ensure that quality telecommunications services are available to low-income customers at just, reasonable, and affordable rates. Lifeline discounts are available to one customer per household at the customer's principal place of residence. The terms and conditions governing the Company's Lifeline service comply with the Federal Communications Commission's orders, rules, regulations, and policies.

4.1.2. Lifeline Service.

Cricket Communications Lifeline service provides the following functions:

1. Access to the public switched telephone network
2. Local usage
3. Dual Tone Multi-Frequency (DTMF) Signaling or its functional equivalent
4. Single-party service or its functional equivalent
5. Access to 911 and E911 emergency service
6. Access to operator service
7. Access to interexchange service
8. Access to directory assistance
9. Text messaging
10. Voicemail
11. Call waiting
12. Caller ID

4.1.3. Lifeline Benefit.

Lifeline customers may select one of seven monthly plans. Under each plan, the customer receives specified services for a fixed monthly charge. The current plans and rates for each plan are set forth in Section 6.

4.2. Eligibility.

4.2.1. A single Lifeline benefit is available for each household and only the head of household may apply for Lifeline service. An individual's eligibility may be program-based by participating in a qualified program or income-based by meeting an income level.

4.2.2. Program-based eligibility: An individual qualifies for Lifeline service if the individual currently participates in one of the following programs:

1. Federal Public Housing Assistance/Section 8
2. Food Stamps
3. Medicaid
4. Low Income Home Energy Assistance Program (LIHEAP)
5. Supplemental Security Income (SSI)
6. National School Lunch (free program)
7. Temporary Assistance for Needy Families (TANF)

4.2.3. Income-based eligibility: An individual qualifies for Lifeline service if the individual has total household income that meets the Federal guidelines for Lifeline service.

4.2.4 A customer must not reside on Federally-recognized Tribal Lands.

4.3. Application.

4.3.1. Any individual applying for Lifeline service must complete an application form. Application forms are available online at www.mycricket.com/lifelinearizona or at a full service Cricket Store

4.3.2. An individual that applies for Lifeline service based on participation in a qualified program must indicate the program in which the individual participates and certify under penalty of perjury that the individual is a participant in the identified program

4.3.3. An individual that applies for Lifeline service based on having a total household income at or below 150% the Federal Poverty Guidelines must provide documentation of income eligibility. Acceptable documentation of income eligibility includes the prior year's state or federal tax return, current income statement from an employer or paycheck stub, a Social Security statement of benefits, a Veterans Administration statement of benefits, a retirement/pension statement of benefits, an Unemployment/Workmen's Compensation statement of benefits or other official document

4.3.4. An individual that applies must certify under penalty of perjury that the individual does not reside on Federally-recognized Tribal Lands.

4.3.5. The Company will determine at its sole discretion whether or not an applicant meets the eligibility requirements to participate in Lifeline service.

4.4. Coverage Maps.

Coverage maps may be found on the Company's website, www.mycricket.com. These maps are for general informational purposes only. Cricket Communications does not guarantee coverage or service availability. Even within a coverage area, factors such as terrain, weather, structures, foliage, signal strength, traffic volumes, service outages, network changes, technical limitations, and equipment may interfere with actual service, quality and availability. Thus, it is possible a phone will roam even in the area depicted as the customer's home calling area. Actual coverage and service areas may vary from the maps and may change without notice. The Company's Lifeline service is available in Arizona only in the wire centers identified in Section 7.

4.5.Limitations of Service and Use of Equipment.

Service is subject to transmission limitations caused by certain equipment and compatibility issues, atmospheric, topographical and other conditions. Further, Service may be temporarily refused, limited, interrupted or curtailed due to system capacity limitations, technology migration or limitations imposed by the Underlying Carrier, or because of equipment modifications, upgrades, repairs or relocations or other similar activities necessary or proper for the operation or improvement of the Underlying Carrier's radio telephone system. The Company does not warrant or guarantee availability of network or of any Services at any specific time or geographic location or that the Services will be provided without interruption. The Company shall have any liability for Service failures, outages or limitations of Service. Because of the risk of being struck by lightning, customers should not use handset phones outside during a lightning storm. Customers should also unplug the handset phone power cord and charger to avoid electrical shock and/or fire during a lightning storm.

4.6.Emergency Calls.

If a customer is in an area where the handset is searching for a wireless signal or there is no wireless signal or wireless service, a call to 911 may not go through. Customers are advised to not rely solely on the handset in an emergency situation and are directed to dial 911 from the nearest landline phone to call for help in an emergency.

4.7.Limitation of Liability.

Cricket Communications will not be liable to customers for any indirect, special, incidental, consequential, exemplary or punitive damages of any kind, including lost profits (regardless of whether it has been notified such loss may occur) by reason of any act or omission in its provision of equipment and Services. SECTION 5. DESCRIPTION OF SERVICES OFFERED.

5.1. Service Description.

5.1.1. A person must submit a Lifeline application, together with supporting documentation (when required), and who meets the eligibility requirements, to receive Lifeline Service from the Company.

5.1.2. To continue qualifying each year for Lifeline Service, each customer will be required and is responsible to re-qualify on an annual basis. If the Company determines that a customer fails to re-qualify for Lifeline service, such customer will immediately be deemed ineligible to participate in Lifeline service.

5.1.3. The Company reserves the right to cancel the enrollment of any customer and/or ban the customer's phone from being reactivated for any fraud related issues as determined solely by the Company. Upon the request of a state and/or federal authority, a Lifeline customer's enrollment may also be cancelled.

SECTION 8: TERMS AND CONDITIONS.

8.1. General Terms.

Cricket reserve the right to cancel offers early or extend offers without notice. Offers may not be available everywhere or combinable with other promotions/options. Coverage is not available everywhere and varies by service - see mapping brochures or visit Cricket's official website (www.mycricket.com) for details. Cricket services may only work with Cricket's phones - not all services are available with all phones, on all networks or within all coverage areas. Monthly service charges are non-refundable even if service is terminated or modified before your billing cycle ends. International roaming rates for voice and data services are additional and will vary. On calls that cross time periods, minutes are generally deducted or charged based on the call start time. Partial minutes of use are rounded up to the next whole minute.

8.1.1. Nature of Service.

The rate plans, devices, services and features are not for resale and are intended for reasonable and non-continuous use by a person using a device on Cricket's networks.

8.1.2. Prohibited Network Uses.

To ensure the activities of some users do not impair the ability of other customers to have access to reliable services provided at reasonable costs, customers may not use the services in a manner that is unlawful, infringes on intellectual property rights, or harms or unduly interferes with the use of Cricket's network or systems. Cricket reserves the right, without notice or limitation, to limit data throughput speeds or quantities or to deny, terminate, end, modify, disconnect, or suspend service if an individual engages in any of the prohibited voice or data uses set forth in the Agreement, Fair Use Policy, Acceptable Use Policy, detailed below or if Cricket, in its sole discretion, determines action is necessary to protect its wireless networks from harm or degradation. **Examples of prohibited voice uses:** Cricket voice services are provided solely for live dialogue between, and initiated by, individuals for personal use and as otherwise described in this policy. Cricket services may not be used for any other purposes, including, but not limited to: monitoring services, transmission of broadcasts, transmission of recorded material, telemarketing, autodialed calls, other commercial uses, or other connections that do not consist of uninterrupted live dialogue between individuals. **Examples of prohibited data uses:** Cricket data services are provided solely for purposes of web surfing, sending and

Our data services may not be used: (i) to generate excessive amounts of Internet traffic through the continuous, unattended streaming, downloading or uploading of videos or other files or to operate hosting services including, but not limited to, web or gaming hosting; (ii) to maintain continuous active network connections to the Internet such as through a web camera or machine-to-machine connections that do not involve active participation by a person; (iii) to disrupt email use by others using automated or manual routines, including, but not limited to "auto-responders" or cancel bots or other similar routines; (iv) to transmit or facilitate any unsolicited or unauthorized advertising, telemarketing, promotional materials, "junk mail", unsolicited commercial or bulk email, or fax; (v) for activities adversely affecting the ability of other people or systems to use either Cricket's wireless services or other parties' Internet-based resources, including, but not limited to, "denial of service" (DoS) attacks against another network host or individual user; (vi) for an activity that connects any device to Personal Computers (including without limitation, laptops), or other equipment for the purpose of transmitting wireless data over the network (unless customer is using a plan designated for such usage); or (vi) for any other reason that, in our sole discretion violates our policy of providing service for individual use. **Unlimited Use Plans.** If you subscribe to rate plans, services or features that are described as unlimited, you should be aware that such "unlimited" plans are subject to these Cricket Prohibited Network Uses.

8.1.3. Messaging (text, picture and video).

Certain messages, including those to third parties to participate in a promotion or other program, will result in additional charges. International messaging rates may vary and are subject to change. There is no guarantee that messages will be received, and we are not responsible for lost or misdirected messages. Most text messages are limited to 160 characters.

8.1.4. GPS /Location Based Services.

Environment may limit GPS/ location based service information. It is the responsibility of the Account holder to notify device users that location can be identified while using GPS / location based service applications.

8.1.5. Data.

Services are not available with all Cricket phones. The amount of data transmitted over our network is measured in kilobytes (KB), megabytes (MB) or gigabytes (GB). Unless specified otherwise 1024KB equals 1MB. 1024MB equal 1GB. Usage is calculated on a per kilobyte, megabyte or gigabyte (depending on rate plan) basis and is rounded up to the next whole kilobyte, megabyte or gigabyte. Rounding occurs at the end of each session or each clock hour and at which time Cricket will deduct accumulated usage from the plan. Account holder is responsible for all data activity from and to its device, regardless of who initiates the activity. Estimates of data usage will vary from actual use. The bill will not separately identify the number of kilobytes, megabytes or gigabytes attributable to the use of specific sites, sessions or services used. Premium content (games, ringtones, songs, etc.) priced separately. Services are not available for use in connection with server devices or host computer applications, other systems that drive continuous heavy traffic or data sessions, or as substitutes for private lines or frame relay connections. Except with phone-as-modem rate plan or feature, customer may not use a phone (including a Bluetooth phone) as a modem in connection with a computer, PDA, or similar device. Cricket reserves the right to deny or terminate service without notice for any misuse or any use that adversely affects network performance.

8.1.6. Web Access.

Cricket can help prevent the transmission of material harmful to minors on certain devices by allowing access to a limited number of Internet web sites or restricting Web access.

8.1.7. Off-Network Usage.

The primary use of Device must be for domestic purposes within the Cricket-owned network. Cricket reserves the right, without notice, to deny, terminate, modify, disconnect or suspend service if more than 50% of the voice and/or data usage is on a Partner network. The display on the device may not always be on and will not indicate whether the user is on a Partner network or roaming. Account holder can monitor usage by calling 800-Cricket and online through MyAccount for certain rate plans. Cricket may limit or terminate service if Account holder no longer lives and has a mailing address within a Cricket owned-network area.

Data services and certain calling features (Voicemail, Caller ID, Call Waiting, etc.) may not be available in all areas. Cricket reserves the right to deny, terminate, modify, disconnect or suspend service if the majority of minutes or kilobytes are used while roaming or on a Partner network.

8.1.9. International Long Distance and Messaging.

8.1.10. Rates and available countries are available at www.mycricket.com. International rates are subject to change without notice.

8.2 Scope of Service.

8.2.1.

Cricket reserves the right to manage its wireless systems and the use of its Services. As a result, Cricket may deny a request for Service from any customer or potential customer or discontinue a customer's service for any lawful reason. Cricket may block access to a number and/or certain categories of numbers (for example, 976 and 900 numbers), certain websites, or certain messages, including text, video, photo, and audio messages, in its sole discretion and to the extent legally permitted. In addition, calls placed to services that, in our sole discretion, are designed to facilitate traffic stimulation, including but not limited to chat line facilities, free conference calling services, call center operations and help desk provisioning, are not included in our calling plans.

8.2.2.

Services are generally available within the operating range of our wireless system in the identified service area. Coverage maps only approximate anticipated wireless coverage area outdoors; actual Service area, coverage and quality may vary and change without notice depending on a variety of factors including but not limited to network capacity, location, nearby buildings (and other structures), the wireless device, terrain and weather. Outages and interruptions in Service may occur, and speed of Service varies. Cricket is not liable for problems relating to Service availability or quality. Except for 911 calls and any "roaming" service to which Account holder has subscribed, Account holder will not be able to use wireless device outside of the service area for any calls (including local and long distance) or any other service features. As a result, sometimes Service, including calls or attempted calls to emergency services like 9-1-1 calls, may be

Any statements by Cricket, its employees, representatives or agents about the coverage of Cricket's wireless system are only intended to describe Cricket's approximate coverage in the service area. Such statement does not that Service will be available under all circumstances, at all times, or without interruption in the service area.

8.2.4.

Account holder will hold cricket, its employees and agents harmless against any and all claims, demands or actions (including actions by third parties or those who use the Account holder phone) arising out of the Account Holder or another person's use or attempted use of the service.

8.3 Rate Plans.

8.3.1.

Crickets rate plans for Arizona are set forth in Section 6 above.

8.3.2.

Certain promotions or rebate offers (instant or otherwise), may apply only to a particular Rate Plan or Service(s) for a certain period of time, or payment options to be eligible.

8.4. Prohibited Uses.

8.4.1.

Users must comply with all laws and regulations while using the Service. Among other prohibited uses, the Service may not be used (1) for telemarketing, commercial research, commercial data collection or transmission, sale or resale of Service or in the operation of any telephone-based business (for example, chat lines or fortune telling services); (2) for any fraudulent, illegal or abusive purpose, or in a manner that interferes or causes problems with the operation of Cricket's wireless system; or (3) continuously, with or without breaks, so as to create the functional equivalent of a telephone line dedicated to continuous use.

8.4.2.

Users must use the wireless device predominantly within the Cricket owned network coverage area. Cricket may limit, deny continued use of the other carrier's network, change the rate plan or terminate Service without notice if Account holder no longer live and have a mailing address within a Cricket owned network coverage area or if more than 50% of your voice and/or data usage is on a Partner network for the previous billing cycle.

8.5. Wireless Devices, Numbers and E-mail Addresses.

Cricket did not manufacture the wireless device and is not responsible for any defects or for the acts or omissions of the manufacturer. The device may not accept services from other carriers. The Account holder does not have any rights to any number, e-mail address or other identifier that Cricket may assign to the device or account; the Account holder may not modify, change or transfer any of these except as Cricket allows and as allowed for by law. In certain instances, the phone number may be transferred from another carrier to Cricket or from Cricket to another carrier.

8.6. Charges.

8.6.1.

The Account holder is responsible for paying all charges for Service, including the following: (1)recurring monthly charges for each monthly billing period in which the Account holder had or will have access to the Service for all or any portion of that billing period; (2) optional Service features or feature bundles selected by the Account holder and for which separate charges apply, including but not limited to long distance, directory assistance (411) calls, ringtones, ringback tones, videos and music; (3) charges for adding multiple phones to the same account; (4) any Service activation, reinstatement, reconnection, administrative, termination or other charges that may apply; (5) all third party charges that the Account holder or user has authorized; (6) all applicable taxes; and (7) regulatory charges, including regulatory charges imposed in connection with Cricket's provision of Service

8.6.2.

Various taxes, surcharges, fees, and other assessments are imposed by governments

relating to the Service, goods or services purchased, and the wireless network and equipment used in providing the Service. Cricket will determine, in its sole discretion, the taxes and other assessments that Account holder is responsible to pay and the amounts of such charges.

8.6.3.

In addition to other charges, Cricket may also assess a "Regulatory Recovery Fee", which is a charge created, assessed and collected by Cricket to help defray costs for compliance with various regulatory requirements which may include, but are not limited to, the capability to provide wireless number portability, number pooling, universal service fees, and surcharges for state/local fees. This fee is not a tax or a government-required charge. In Cricket's discretion, Cricket may change the amount of the Regulatory Recovery Fee.

8.6.4.

For Rate Plans that include per minute airtime access charges the length of a call will be rounded up to the nearest minute and applied against the Services purchased. Charges for a completed call or data services from the wireless phone will begin upon pressing the SEND key and will end when either party ends the call.

8.7. Account Activity, Credit Verification and Release of Information.

Cricket reserves the right to deny or limit the provision of Service on the basis of any information that gathered. Cricket may take any action permitted by law that Cricket believes is necessary to verify your identity, address, age, account activity or credit, and Cricket may take that action at any time. Cricket may require that the Account holder provide additional or updated information Cricket reasonably needs to determine if Account holder qualify for Service, to manage the Service, or to determine if Account holder is using the Service in accordance with this Agreement. If Account holder does not provide us the information Cricket requested within the time period specified, Cricket may choose not to start Service, or, for an existing customer, Cricket may suspend or terminate Service.

8.8. Billing and Payment.

8.8.1.

Unless on a prepaid plan, monthly Service charges are generally billed in advance, and payment is due on or before the date due as stated in the bill. The monthly service periods are approximately thirty (30) days long. Monthly service period and other dates related to the account may change from time to time. Account holder may be required to pay a convenience/processing fee for some methods of payment or for the use of some payment locations. Account holder must strictly comply with any and all requirements and conditions imposed by Cricket under any such agreement or arrangement and the terms, conditions, duration and frequency of such agreements or arrangements shall remain at Cricket's sole discretion.

8.8.2.

Account holder may authorize recurring payment of your Cricket bill by credit card ("Credit Card"); this authorizes us to charge all amounts owed Cricket to the Credit Card up to seven (7) days prior to the due date and to demand immediate payment from the card issuer. Unless required by law, Cricket will not have to give any additional notice or obtain additional consent before billing that Credit Card for Service each month. Account holder may also pay your Cricket bill (1) by mailing a check or money order; (2) in person at any Cricket authorized payment center; (3) over the phone; or (4) at the official website (www.mycricket.com). There may be an additional convenience/processing fee, depending on the payment method. In addition, Cricket may charge an additional fee up to the maximum amount permitted by law for any check or other negotiable instrument tendered and returned unpaid by a financial institution for any reason. Cricket reserves the right, in its sole discretion, to require that payments to Cricket be by cash, certified check, cashier's check or money order.

8.8.3.

Payment will be considered late if Cricket does not receive it before the first day of the monthly service period for which the payment is due. If payments are not made when they are due, Account holder will be in default under this Agreement, and Cricket will be entitled to exercise any rights Cricket may have under this Agreement, including the suspension or termination of Service. If Cricket accepts a late or partial payment,

even if Account holder marks the payment "paid in full", Cricket does not waive its rights to suspend or terminate Service or any other rights it may have. If Cricket has to take action beyond billing in order to collect payment, Account holder will be required to pay reasonable costs and expenses of collection, including attorney's fees, court costs, and the fees of any collection agency to the extent permitted by law. If Cricket bills and collects amounts for any third party service provider, Cricket will allocate payments received first to amounts due to Cricket. Account holder have the right to dispute charges on your bill, but must notify Cricket of the dispute within sixty (60) days after the billing date or you waive any claim you may have had. Even if you have a dispute with us, you have to pay all charges on time until the dispute is resolved.

8.8.4.

Amounts paid for service charges are non-refundable. if service is terminated for any reason and you have a positive balance in your service account or flex bucket services account, you will not be entitled to receive any refund.

8.9. Termination.

8.9.1.

Cricket may terminate or suspend Service at any time and for any reason without liability.

8.9.2.

Account holder may terminate Service at any time by notifying a Cricket customer service representative. If this agreement terminates for any reason, you will no longer be entitled to access any services (including but not limited to flex bucket services) and will not be entitled to receive any refund of any payments made for monthly service, upgrades, enhancements, fees, for any other prepaid service, or for any other reason.

8.10. Limitations of Liability.

Unless the law forbids it in any particular case, Account holder's claims for damages or other monetary relief against cricket and its vendors and suppliers are limited to the lesser of: (a) Account holders direct damages or (b) one month's service charges. this limitation and waiver will apply regardless of the theory of liability, whether fraud, misrepresentation, breach of contract, personal injury, negligence, products liability, or
