The utility has 5 wells, and all of the well meters need to be replaced as they all have either not worked or intermittently worked during the year. Bob White and Bensch Ranch wells are rarely used and the meters are inoperable. These wells contributed an estimated 5 million gallons during peak summer usage. Gold Pan's meter is also inoperable, but is estimated to have contributed about 6.5 million gallons. Trails End and Duffers are the main production wells. Duffers pumped 13,083,900 during the year and the Trails end meter only captured 4,368,286 gallons. Trails End gallons pumped should be closer to 20 million gallons. Bradshaw will be filing a rate case and new well meters will be included in the financing portion.
