I. LIMITATIONS ON SERVICE

1. Due to the capacity limitations on the Company's transmissions and booster facilities, water service within the Company's certificated area is limited as follows:

A. Additional Customers.

No additional Customers shall be added to the Company's existing water system, nor shall customers at the existing meter locations serve additional residences or structures that use additional water.

B. Location.

All water provided through Company meters shall be used exclusively within the certificated area of the Company.

C. Number of Meters.

No customer shall request, and the Company shall not install, any additional meter(s) at existing service locations, nor shall it replace existing meter(s) with larger meters than in service on July 1, 1998, without written permission from the Commission's Utilities Division Staff or upon the Customer's compliance with Paragraph H below.

D. Gallonage Limitation.

Customers are restricted to their historic average daily consumption levels, not to exceed 105% of the average of the consumption for each day during each distinct billing period as recorded in the Company's records for the calendar years 1996, 1997 and 1998.

E. <u>Maximum Gallonage Consumption</u>.

Within thirty (30) days of the effective date of this tariff, the Company shall provide notice to each Customer of the average daily consumption that will be the maximum permissible delivery to that service location.

F. Special Equipment Required.

Customer shall receive service only through special equipment installed by the Company and designed to optimize service to the Customer via the limited transmission capabilities of the system. Said equipment shall be owned and maintained by the Company. The equipment shall be located at a mutually agreed upon site on the customer's property. Customer shall provide the electrical connection for the pressure pump and shall be responsible for payment of the power and energy costs for that pump. Each customer shall be served through the following facilities, configured in the following sequence.

- (i) Company owned service line.
- (ii) An orifice restricting the gpm water flow.
- (iii) 5/8" by 3/4" water meter.
- (iv) Back flow/air gap device.
- (v) Self filling storage tank.
- (vi) Maximum 20 gpm pump.
- (vii) Customer owned service line to residence/building.

G. Violation.

In the event a Customer either exceeds the Maximum Gallonage Consumption levels set forth in Paragraph E above for any two billing months during any calendar year, or violates the Curtailment Program as set forth below, the Customer is subject to termination of service upon thirty (30) days written notice.

H. Exception.

(a) The limitations set forth in Paragraphs A, B, C, D and F above shall not apply if the Customer agrees to enter into a Line Extension Agreement with the Company under which it advances all costs incurred by the Company to install sufficient production/booster/storage facilities necessary to meet the Customer's additional requirements.

I. Curtailment Program.

In the event the production, transmission, storage, or booster facilities of the Company will not maintain a minimum 20 psi delivering pressure at the existing customer consumption levels, the Company is authorized to implement a curtailment program, under which it will require its customers to limit water usage in the following manner:

(a) Phase I: During curtailment, water usage levels shall be imposed on all customers on a rolling basis. Customers shall be grouped into two groups. Group A shall consist of Parcels 1, 2, 4 and 9, as set forth in Paragraph K. Group A shall be limited to domestic water consumption during the hours of 5:00 a.m. to 5:00 p.m. on odd-numbered calendar days. On odd-numbered calendar days group B shall have no such limitation, but is encouraged to curtail usage to the extent possible.

Group B consists of Parcels 3, 5, 6, 7, 8, 10 and 11 as set forth in Paragraph J and shall be limited to domestic water consumption only during the hours of 5:00 a.m. to 5:00 p.m. on even-numbered days. Group A shall have no such limitation on even numbered days, but is encouraged to curtail usage to the extents possible.

- (b) Phase II: In the event curtailment under Phase I does not permit operation at 20 psi pressure, Phase II shall be implemented for all customers which shall include all Phase I provisions, and in addition customers shall not irrigate crops, plants, or lawns, nor shall they wash vehicles and equipment during Phase II.
- (c) Phase III: In the event Phase II curtailment does not provide 20 psi delivering pressures, Phase III shall be implemented. Phase III shall consist of all provisions of Phase I and II, plus, all livestock watering shall be discontinued.

Customers shall be notified telephonically or by hand delivery no less than 24 hours before the implementation of any phase of curtailment, PROVIDED HOWEVER, if an operating emergency occurs on the System which is not foreseeable by the Company, the curtailment may be immediate. In that event, written/telephonic notice shall be provided to the customers as soon as practicable.
