“*Major stockholder*” means a shareholder possessing or controlling twenty per cent of the issued and outstanding shares or twenty per cent of any proprietary, beneficial or membership interest in the corporation. “*Controlling*” includes the total shares of stock issued to a husband and wife and their relatives to the first degree of consanguinity.

NOTE – if a major stockholder is a corporation, you must list the current president, chairman of the board of directors, and major stockholders of the corporation that is the major stockholder.
