NOTICE OF HEARING

A PUBLIC HEARING WILL BE HELD before the Arizona Power Plant and
Transmission Line Siting Committee (“Committee”) regarding the Application of Vulcan
Solar Project, LLC (“Applicant”) for a Certificate of Environmental Compatibility
(“CEC”) authorizing construction of the Vulcan Interconnection Project (“Project”).

The Project involves the construction of a single circuit alternating current 500
kilovolt transmission line that will connect the Vulcan Energy Center—a utility-scale energy
facility incorporating solar photovoltaic generation and battery energy storage equipment—
to the existing Salt River Project Hassayampa Switchyard. The Project is located
approximately 15 miles west of the City of Buckeye in unincorporated Maricopa County,
Arizona. A map of the Project is attached as **Exhibit A**.

1 The hearing on the Application will be held at the Hampton Inn and Suites located
2 at 2000 N. Litchfield Road, Goodyear, Arizona 85395. **The hearing will begin on**
3 **Monday, February 23, 2026, at 1:00 p.m. and will continue as necessary through**
4 **Friday, February 27, 2026, beginning at 9:00 a.m. each day at the same location until**
5 **completion of the hearing.** If any revisions to the hearing schedule are required, they will

21 The Chairman may, at his discretion, recess the hearing to a time and place to be
22 announced during the hearing, or to be determined after the recess. The date, time, and
23 place at which the hearing will be resumed will be posted on the above-noted Project and
24 ACC websites. **NOTE: NOTICE OF ANY SUCH RESUMED HEARING WILL BE**
25 **GIVEN; HOWEVER, PUBLISHED NOTICE OF SUCH RESUMED HEARING IS**
26 **NOT REQUIRED.**

Each county, municipal government, and state agency interested in the Project that desires to be a party to the proceedings shall, not less than ten (10) days before the date set for the hearing, file a Notice of Intent to Become a Party with the Director of the Utilities Division, ACC, 1200 West Washington Street, Phoenix, Arizona 85007.

Any domestic non-profit corporation or association formed in whole or in part to promote conservation or natural beauty; to protect the environment, personal health or other biological values; to preserve historical sites; to promote consumer interests; to represent commercial and industrial groups; or to promote the orderly development of the area in which the Project is to be located desiring to become a party to the proceedings shall, not less than ten (10) days before the date set for the hearing, file a Notice of Intent to Become a Party with the Director of Utilities Division, ACC, 1200 West Washington Street, Phoenix, AZ 85007.

The Committee may make other persons parties to the proceedings at any time. Any person may make a limited appearance at a hearing by filing a statement in writing with the Director of the Utilities Division, ACC, 1200 West Washington Street, Phoenix, AZ 85007, and the Chairman of the Committee at 2005 North Central Avenue, Phoenix, AZ 85004, not less than five days (5) before the date set for the hearing. A person making a limited appearance will not be a party or have the right to present testimony or cross-examine witnesses.

1 This proceeding is governed by Arizona Revised Statutes ("A.R.S.") §§ 40-360 to
2 40-360.13 and Arizona Administrative Code R14-3-201 to R14-3-220. No substantive
3 communication, not in the public record, may be made to any member of the Committee.
4 The written decision of the Committee will be submitted to the ACC pursuant to A.R.S. §
5 40-360.07. Any person intending to be a party to the proceedings on the matter before the
6 ACC must be a party to the proceedings before the Committee.

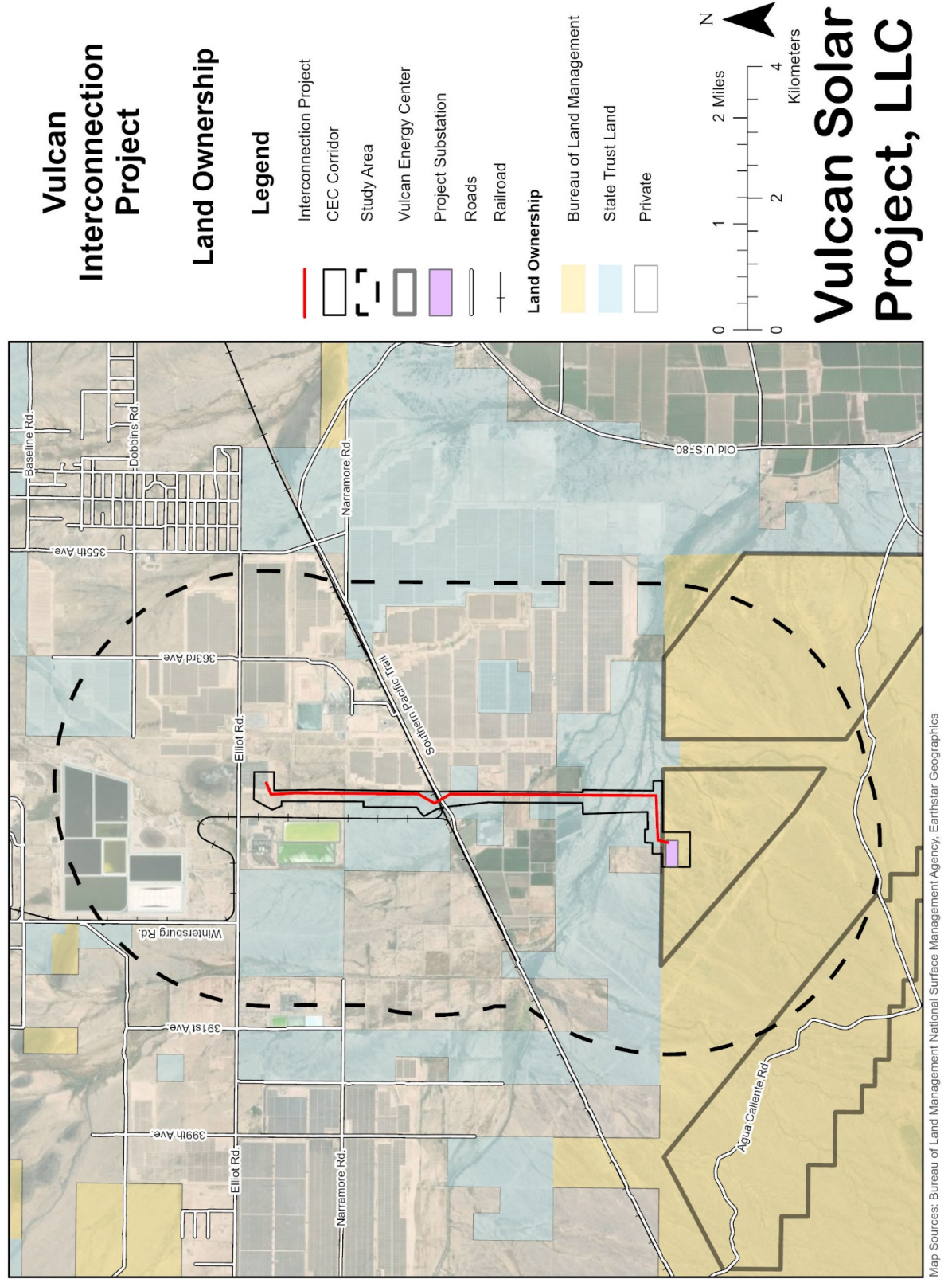
