NOTICE OF HEARING

A PUBLIC HEARING WILL BE HELD before the Arizona Power Plant and Transmission Line Siting Committee ("Committee") regarding the Application of Belmont Energy Center, LLC, ("Applicant") for a Certificate of Environmental Compatibility to authorize construction of the Belmont Solar Project, a proposed new up to 8.6-mile 500-kilovolt alternating current generation intertie transmission line and associated substation facilities ("the Project"). The Project is designed to deliver power from a 450-megawatt ("MW") solar photovoltaic facility with a 450-MW storage system to the existing APS Delaney Substation. The Committee or the Chairman, at any time deemed appropriate, may make other persons parties to the proceedings.
