Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee (“Committee”), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the High Country Conference Center, 201 West Butler Avenue, Flagstaff, Arizona 86001, commencing on September 16, 2019 at 1:00 p.m., and will continue each weekday on September 17, 2019 through September 18, 2019, as necessary, at the same location beginning at 9:00 a.m. on each day, unless a tour is taken. If a tour is taken, it will begin on September 17, 2019, at approximately 7:00 a.m. or an alternative date and time set by the Chairman of the Committee (“Chairman”). If necessary, the hearing will continue September 19, 2019, at 9:00 a.m. at the Aspen Room, 2223 East 7<sup>th</sup> Avenue C, Flagstaff, Arizona 86004. Public comment will be taken in a special evening session on September 16, 2019 at 6:00 p.m. at the High Country Conference Center, 201 West Butler Avenue, Flagstaff, Arizona 86001 and may be taken at the beginning of each hearing day or at other times

1 during the hearing at times designated by the Chairman. Unless later ordered by the  
2 Chairman, the hearing will adjourn at approximately 5:00 p.m. each day.

3 Additional days for the hearing may be set, and the hearing may conclude earlier  
4 or later than anticipated, depending upon the number of parties that intervene, the  
5 amount of testimony presented, the amount of public comment, and the time needed for  
6 deliberations by the Committee. As a part of the public meeting/hearing, members of  
7 the Committee will discuss the potential value of a tour, and, at the discretion of the  
8 Chairman, may tour the location of the proposed power plants and transmission lines for  
9 the project as set forth above.

10 At the public meeting/hearing, the Committee may consider, discuss, deliberate  
11 and/or vote on the matters on the agenda. Items on the agenda may be taken in a  
12 different order than listed as conditions require:

- 13 1. Call to order;
- 14 2. Roll call;
- 15 3. Consideration of and vote upon any requests to intervene;
- 16 4. Hearing on the application;
- 17 5. Public comment at the discretion of the Chairman;
- 18 6. Discussion of potential value of a tour of the proposed route;
- 19 7. If it is decided a tour would be valuable, the Committee will meet at the  
20 hearing site. The members of the Committee will tour the project. Members  
21 of the public may follow the Committee's tour. No testimony or discussion  
22 with or between Committee members about the application or matters relating  
23 to the application will take place, except on the record before a court reporter  
24 at the designated stops. The Chairman will make any procedural decisions  
25 concerning stops at different points of interest;


